Mandatory Paid Leave – The Veto and a State Survey

House Bill No. 1, “Maryland Healthy Working Families Act,” would have required all employers with as few as 15 employees to provide up to five days of paid time off each year for those who work an average of 12 hours or more per week.

In late May Governor Larry Hogan vetoed HB-1, but that does not mean the battle is over. As part of his effort to sustain that veto, the Governor issued an executive order to collect data and information to understand the access workers in Maryland have to paid leave and what burdens and hardships imposing a one size fits all requirement places on businesses.

As part of Gov. Hogan's Executive Order, the Department of Labor, Licensing and Regulation has opened an eight-question survey to help shape policy on paid leave. You can take the survey here: <http://www.doit.state.md.us/selectsurvey/paidleave#>

The Executive Order also required the formation of a field study to help determine an approach that would be healthier for employers. The governor had proposed his own bill which, among other differences from HB- 1, pushed the minimum number of employees to 50 instead of 15. He plans to introduce emergency legislation at the beginning of the 2018 legislative session to address paid leave.

Beyond taking the survey, if you have any stories or information that might help on this question of mandatory leave please let me know and I will pass it on.



St. Mary's CDC Completes First Public Art Project in Lexington Park



At the corner of Great Mills Road and Shangri-La Drive/Willows Road the winning "Lexington Park Alive!" mural is complete. This first public art project produced by the St. Mary's County Community Development Corporation follows the corporation's inaugural ArtsPark Cherry Blossom Festival in April.

The CDC's ArtsPark committee, in a juried contest, selected Lyn Wescoe's design from 10 submissions. Three additional submissions have also found homes. Ms. Wescoe's design depicts everything from an Amish buggy, crabs, and jelly fish to the cutting-edge aircraft from Pax River and the sweeping Thomas Johnson Bridge connecting St. Mary's and Calvert counties. The mural follows her design's dramatic black and white portrayal of Lexington Park and its surrounds.

A two-week flurry of activity by local artists and a wide array of community volunteers reproduced the design on the rear of Bank Square Building, beginning with the nighttime projection and tracing of the design on the prepped cinderblock wall.

The 15-foot by 50-foot mural is visible from the busy Great Mills Road intersection, two blocks south of NAS Patuxent River's Gate 2. But already it has drawn patrons off the road and into Mr. Tire's parking lot to take a closer look and to take pictures with the mural as backdrop.

St. Mary's College Professor Carrie Patterson's Public Art Class both opened the flurry of activity with the tracing and helped put the finishes touches on the mural two weeks later. Roz Racanello, CDC's ArtsPark project manager, was the primary artist transferring the design into the mural. She received help from many others, including former St. Mary's County Commissioner President Jack Russell with the painting assistance of Tim Dixon, St. Mary's Arts Council Executive Director Nell Elder, and even a few brush strokes from Lexington Park's County Commissioner Todd Morgan.

In addition to support from St. Mary's CDC, the mural was generously funded by grants from the St. Mary's Arts Council and the Southern Maryland Heritage Area.

The Lexington Park library is additionally supporting two of the design submissions. One appears on the recently opened Little Free Pantry sponsored by the MOMS Club of St. Mary's County and located at the Lexington Park library. A second submission will become a public art display inside the library.

Leonardtown's Benjamin Moore, Dyson's Building Center, and Lexington Park Sherwin Williams stores donated the necessary supplies. Cooperation and support from Stevens Construction, Essex South, Earley Properties, and Mr. Tire made production of the mural possible.

In its efforts to bring art into Lexington Park as a revitalization tool, St. Mary's CDC continues to seek additional public art productions and is working to create an ArtsPark from a vacant 35 acres next to the Lexington Park Post Office on Coral Drive.

CSM Partners With Seafarers Harry Lundeberg School of Seamanship New Associate Degree in Maritime Operations Technology Now Offered

The College of Southern Maryland (CSM) has established a new partnership with the Seafarers Harry Lundeberg School of Seamanship (SHLSS) in Piney Point. Representatives from both of the educational institutions signed a memorandum of understanding about the new relationship at the Piney Point facility June 5.

Students in the one-year apprenticeship program at the SHLSS are training for entry-level positions in the U.S. merchant marine. Starting this fall semester, the partnership with CSM will enable those students to also earn college credit and work toward an associate of applied science degree in Maritime Operations Technology, with an option of a degree in either nautical science or marine engineering. Under this new partnership, CSM will provide the general education courses and SHLSS will provide the technical courses.

"I thank CSM for providing the opportunity for our members and your prospective students. This program is going to be a benefit for our membership," said SHLSS Vice President Tom Orzechowski. "It will enhance their ability to work toward their degree."

"I'd like to second your feelings. This is important for the college," said CSM President Dr. Bradley Gottfried at the signing. "It's all about workforce development ... working with the community. This is such an important facility in Southern Maryland, and for us to be able to work with you on this partnership means so much for our students." The partnership expands CSM's student population and establishes a valued community connection. Initially, the program will begin with CSM faculty teaching Composition and Rhetoric (ENG 1010) for three credits and Math for Technologies (MTH 1011) for four credits at the Piney Point facility. In addition, tutoring will be offered to assist students in those classes.

Representatives from SHLSS and CSM have discussed the possibility of a partnership for 18 months. "They were very interested in having more options for the students," said CSM Vice President/Leonardtown Campus Dean Dr. Tracy Harris. "It's developed into a customer-friendly, student-friendly program. I think it will be something very special ... It's a wonderful opportunity for both them and us."

Harris noted that the partnership between the college and the seafaring school will also help area residents be more aware of the programs offered at the Seafarers Harry Lundeberg School of Seamanship. "It will open eyes," he said.

The Seafarers Harry Lundeberg School of Seamanship is affiliated with the Seafarers International Union of North America, Atlantic, Gulf, Lakes and Inland Waters, AFL-CIO (SIU). It is a vocational school that for the past 50 years has been dedicated to preparing students for careers at sea. The SHLSS provides entry-level training for individuals who wish to begin a seafaring career as well as classes for experienced seafarers to permit them to upgrade their skills.

The SHLSS is located on the campus of the Paul Hall Center for Maritime Training and Education, which consists of more than 60 acres on the waterfront in Piney Point.

CSM is a regional community college serving Calvert, Charles and St. Mary's counties. CSM serves more than 25,000 credit and continuing education students at its campuses in Leonardtown, La Plata and Prince Frederick, and at its new Regional Hughesville Campus. Newly appointed by Gov. Larry Hogan to serve CSM as trustees with his term to begin in July is James Di Misa of Charles County. He will replace Middleton whose term expires June 30.

At their June 15 board meeting, the trustees honored outgoing trustee Middleton, a life-long resident of Charles County, for his service with board emeritus status. Middleton served as CSM trustee since 2007, and was chair of the trustees 2013-15 and vice chair, 2012-13. Referencing his service as a trustee, Board Chair Dorothea Smith said, "During his tenure, Trustee Middleton has been diligent in promoting the mission of the board of trustees in its responsibilities to proactively govern the College of Southern Maryland, ensure institutional integrity and promote excellence of post-secondary education in meeting the needs of the Southern Maryland community."

His vision and understanding of the needs of the community have resulted in the regional campus located in Hughesville which is lauded by all segments of the population. Being an active participant in his community, Dr. Gottfried also initiated three institutes – the Nonprofit, Diversity and the Entrepreneur and Innovation institutes – to better serve the community. He has demonstrated love for education and his legacy of building for the future will continue on at the college."

Upon Gottfried's retirement, incoming CSM President Dr. Maureen Murphy will assume the role of secretary/treasurer to the board, effective July 1.
